The Technical Evaluation Committee of Group A informed in the meeting that since it was not stated in the bid that bidders are required to submit notification of the varieties, bidders did not submit the same. However, it created difficulty in evaluation to find out if the variety is notified for the state or not.

In this context the Price Finalisation Committee directed MD, ASC Ltd. to ascertain the same from Assam Agriculture University and finalise the technical responsiveness/non responsiveness of the bid in this respect.
