







The Chairman, Departmental Bid Committee presided over the meeting.

An urgent meeting was called by the Member Secretary of Bid Committee to comply with the Hon'ble High Court Order WP© NO. 3926/2019 (M/s TERONPI'S ENTERPRISE Vs THE STATE OF ASSAM AND 3 OTHERS. Honourable High Court has directed the respondents to treat the price bid of the petitioner as responsive and thereafter issue necessary supply order. The members of the committee has reviewed the financial evaluation of group-A-I A-II and declared M/s Teronpi's Enterprise as responsive for the crops quoted in Group A(I) and Group A(II) respectively. In the meeting it was decided that since the firm has not quoted the quantity separately for the varieties, the quantities will be distributed equally between quoted varieties and the unit price will be the same for both the varieties.
